DEAN'S FUNDRAISING REPORT FOR 2021-2022



Dear Alumni and Friends:

This was a year of both great challenge and great success for the law school. Emerging from the COVID-19 pandemic, the reputation of our outstanding students, faculty and alumni continues to blossom. We continue to attract some of the strongest students, as well as have had consistently strong bar passage and placement rates.

Private fundraising makes a critical difference at the law school, helping us to attract and to support the best students and faculty.

TOTAL GIFTS AND PLEDGES

Putting annual giving and larger gifts together, we raised a cash total of \$3,944,531 and unrealized new pledges in the amount of \$2,466,182, for a grand total of \$6,410,713.

ANNUAL GIVING FROM ALUMNI

This past year, 17.29% of our alumni made cash gifts to the law school. This level of participation places us within the nation's top law schools in terms of alumni giving rate. This level of alumni contributions enriches the life of the school and sends a powerful signal about the enthusiasm our alumni have for the school.

GIVING FROM STUDENTS

This past year, 68.2% of our students participated in the Student Give Back Campaign. Our student enthusiasm and generosity bodes well for the future. They are blazing the trail for us all!

LARGER GIFTS

This past year, cash payments received totaled \$2,978,816 towards \$5,445,000 of Larger Gift commitments. The "Cash Gifts By Level" portion of this report includes only cash payments made during the fiscal year, even if they were but a portion of a larger gift. Under the heading of "Recent Larger Gifts," we outline the larger gift commitments that we received in the 2021-2022 fiscal year.

ENDOWED GIFT OPPORTUNITIES

ENDOWED SCHOLARSHIPS

Our single greatest need from private giving is endowed scholarships. To continue to serve our mission of providing access to all, including those from families of modest means, we will need significantly more scholarships. Scholarships are awarded according to the intent of the donor and may be based on merit, need, or other factors. *The endowed scholarship would be named after you or your designee.*

Minimum gift needed to create an endowed scholarship: \$50,000 (may be paid over time)

ENDOWED PROFESSORSHIPS AND CHAIRS

According to a 2018 study of law faculty scholarly impact, our faculty is #1 in Florida and #29 nationally. Our faculty members are being recruited by some of the nation's most prominent law schools. Endowed professorships and chairs provide salary supplements based on merit. Faculty members are appointed for five-year terms, with renewal contingent on continued scholarly productivity. Professorships and chairs give us the merit money we need to retain our top faculty. *The professorship or chair would be named after you or your designee.*

Minimum gift needed to endow a professorship: \$250,000 (may be paid over time)

Minimum gift needed to endow a chair: \$2,000,000 (may be paid over time)



The Edward Ball Eminent Scholar Chair in International Law has been instrumental in keeping **Frederick M. Abbott** at Florida State. He is highly regarded for his work in international intellectual property rights and global economic issues.

ENDOWMENTS FOR EXCELLENCE

Endowments for excellence are used, at the discretion of the law school, for purposes such as student scholarships, faculty incentives, general discretionary dollars, and funding for co-curricular activities including *Law Review*, Trial Team, and Moot Court. *The endowment for excellence would be named after you or your designee.*

Minimum gift needed to create an endowment for excellence: \$30,000 (may be paid over time)



Kelli Alces Williams, the Kelli Alces Williams, the Matthews & Hawkins professor of property, is an expert on corporate governance, fiduciary duties, trust, and consumer expectations in sophisticated markets. A professorship helps recruit and retain scholars like Williams.

ENDOWMENTS FOR PARTICULAR PROGRAMS

Private philanthropy has helped us take many of our existing programs to a new level of excellence. Our award-winning Moot Court and Trial Teams benefit from private contributions to supplement the dollars available to them for purposes such as traveling to regional and national competitions. Our Public Interest Law Center, which includes the Children's Advocacy Clinic, Claude Pepper Elder Law Clinic, Farmworker & Immigration Rights Clinic, and International Human Rights Clinic, relies on private contributions to help pay for some of the expenses involved in training students to provide effective legal services to the under-represented. An important goal of the law school is to raise substantial endowments to support special programs and co-curricular organizations. Some programs simply would not exist at the law school but for the generous support of our alumni.

Minimum gift needed to create an endowment to benefit a particular program: \$30,000 (may be paid over time)

DONOR RECOGNITION

We are delighted to recognize scholarships, professorships and other targeted gifts by naming them in honor of the donor or the donor's designee. In addition, we are pleased to acknowledge inter vivos gifts of \$200,000 or more with an oil portrait of the donor or the donor's designee that will be displayed in a prominent place at the law school. The Advocacy Center and the renovated spaces in the main classroom building give us many rooms to name to thank donors for gifts ranging from \$25,000 to \$5 million.

LARGER GIFTS FOR 2021-2022

We would like to specially thank those of you who made a larger gift commitment between July 1, 2021, and June 30, 2022. These gifts make it possible to continue the dynamic advancement of the academic programs and reputation of the law school.

An **anonymous donor** has pledged **\$2,000,000** to establish the Talbot “Sandy” D’Alemberte Distinguished Endowed Chair. In memory of Sandy D’Alemberte, the gift will allow the College of Law to recruit a legal scholar who has an expertise in constitutional law and shares D’Alemberte’s passion for freedom of speech.

An **anonymous donor** has made an additional deferred gift of **\$1,000,000** as well as a pledge of **\$50,000** to their already established fund. The fund will provide financial support for law students participating in public interest internships or externships.

Jeff (‘84) and **Aggie Stoops**, through the **Stoops Family Foundation**, have pledged **\$1,000,000** to establish the new Stoops Center for Law and Business. The center will leverage the school’s current strengths to become a nexus of thought leadership and training in business law and compliance for academics, students, lawyers, and business professionals. This important addition to the law school will be a valuable resource for the business community, and likewise, will increase the reputation of FSU Law and our students by showcasing our community on a national scale. Jeff is currently the

president and CEO of SBA Communications, a leading independent owner and operator of wireless communications infrastructure.

Mark Ellis (‘84) has made a deferred gift of **\$250,000** as well as outright contributions of **\$35,000** to his already established Talbot “Sandy” D’Alemberte/Mark Ellis Travel Fund. In memory of Sandy D’Alemberte, the fund offers financial support to law students undertaking international internships in human rights law. Ellis has served as executive director of the International Bar Association since 2000. He is a member of the College of Law’s Alumni Association Board of Directors and serves as an adjunct professor.

James Anderson (‘74) and **Angela Lupo-Anderson** have pledged **\$200,000** to establish the James W. Anderson and Angela Lupo-Anderson, PhD, Scholarship in Law. The scholarship will support students based on merit, financial need, or veteran status. Jim is a retired partner of Savlov & Anderson P.A., where he focused his practice on eminent domain law. Prior to private practice Jim served the Department of Transportation for over a decade.





The **Florida Beer Wholesalers Association** (FBWA) has donated **\$200,000** to establish the Mitchell J. Rubin Scholarship in Law. In memory of Mitchell J. Rubin, the scholarship will support students who wish to pursue a career in governmental affairs, business, environmental, or medical organizations. Rubin was the longtime president of the FBWA, a recognized expert on Florida's beverage law, and a beloved friend and colleague.

Salesia Smith-Gordon ('92) has pledged an additional **\$165,000** to her already established Salesia V. Smith-Gordon Endowment. The fund provides support to the College of Law's Delores Poindexter Auzenne Chapter of the Black Law Students Association (BLSA). Smith-Gordon is the founder of Smith-Gordon Law, where she focuses her practice on plaintiff injury law. She served as the first president of the College of Law's Black Alumni Network and is a member of the College's Alumni Association Board of Directors and Board of Visitors.

David ('72) and **Deborah Fonvielle**, through **The Fonvielle Foundation**, have donated an additional **\$100,000** to their already established David and Deborah Fonvielle Professorship in Law. The professorship supports a legal scholar who specializes in some

aspect of litigation. Fonvielle is retired partner of Fonvielle, Lewis, Messer & McConnaughay, where he focused his practice on plaintiff injury law.

Manuel "Manny" Farach ('86) has pledged an additional **\$75,000** to his already established Farach Family Endowed Scholarship. The scholarship provides support to students who are interested in, and have demonstrated a commitment to, practicing real estate law. Manny is a shareholder at Mrachek Law in West Palm Beach where he focuses his practice on representing businesses and individuals seeking help with complex real estate, business, and appellate issues. He is a member of the College of Law's Board of Visitors.

David Varet ('12), through the **Middle Road Foundation**, has contributed an additional **\$55,000** to the Raising the Bar Professionalism Program. The program exposes law students in all three years to professional development resources and to lawyer role models to prepare them for a life in law. Varet is an assistant regional counsel with the Office of Criminal Conflict and Civil Regional Counsel's 5th District Office in Orlando. He is a member of the College of Law's Board of Visitors and the College's Alumni Association Board of Directors.

Pat Roberts has donated a gift in kind valued over **\$65,000**. The collection of memorabilia includes one-of-a-kind courtroom sketches that depict hearings related to the recount dispute in Florida's year 2000 presidential election between George W. Bush and Al Gore before the United States Supreme Court and the Florida Supreme Court. The collection also includes an original voting "machine" used in Palm Beach County that was accompanied by a voting ballot and "hanging chad." The gift was made in memory of Talbot "Sandy" D'Alemberte who, among other accolades, became nationally recognized for spearheading the efforts to open all of Florida's state courts to television cameras. Roberts has served as the president and CEO of the Florida Association of Broadcasters since 1988.

Alejandro Espino ('97) has pledged **\$50,000** to establish the Luis A. Espino, III Endowed Memorial Scholarship. In memory of Luis A. Espino, III ('94) (1969 – 2012), the scholarship will support Hispanic students at the College of Law. Luis was a proud and loving father, devoted husband, and a partner of Fowler Rodriguez Valdes-Fauli. Alejandro is member of the College of Law's Alumni Association Board of Directors, and a partner at Taylor Espino Vega, PLLC, where he focuses his practice on the construction industry.

Dean Erin O'Hara O'Connor, Michael O'Connor, and Mark Ellis ('84) have pledged **\$50,000** to establish the President John Thrasher Scholarship in Law. The scholarship will provide access to legal education to students who have been historically underrepresented in the legal profession. The O'Connors and Mark Ellis established the scholarship to welcome former President John Thrasher ('73) to the College of Law faculty after his FSU presidency. Dean O'Connor has served as dean of the College of Law since 2016. Ellis serves as executive director of the International Bar Association in London, England, is a member of the College of Law's Alumni Association Board of Directors, and serves as an adjunct professor.

Dean, Mead, Egerton, Bloodworth, Capouano & Bozarth, P.A. has pledged **\$50,000** to establish the Dean Mead Memorial Scholarship in honor of Mark E. Holcomb. In memory of Mark E. Holcomb ('85), the fund permanently endows the book award for the State and Local Taxation course in his name and supports the College of Law's general scholarship fund. Holcomb was a dedicated father and husband, a community leader having served on numerous local boards and his church, and a shareholder of Dean Mead, where he focused his practice on state and local tax law.

Harold Saul ('88) has pledged an additional **\$25,000** to his already established Harold A. Saul Endowment for Excellence and **\$15,000** to sponsor a book award in Trial Practice. Endowments for excellence support the College of Law in the areas of greatest need. Harold is a partner at Kubicki Draper in their Tampa office, where he focuses his practice primarily on insurance defense.



Judge Ryon ('94) and **Jennifer McCabe** have donated **\$30,000** to establish the Pay it Forward Travel Abroad Fund. The fund will provide financial support to a law student who demonstrates financial need and is participating in an international program as part of their legal education. Ryon was once the beneficiary of similar goodwill and was encouraged to "pay it forward" when he could. He currently serves as a judge magistrate for the United States District Court in the Southern District of Florida. Prior to joining the bench, Ryon was a founding member of McCabe Rabin, P.A., where he focused his practice on business and securities law.

Margaret "Peggy" Rolando ('78) has made an additional contribution of **\$30,000** to her already established Peggy Rolando Endowment for Excellence. Endowments for excellence support the College of Law in the areas of greatest need. Peggy is a partner in the Miami office of Shutts & Bowen LLP, where she is a member of the Real Estate Practice Group. She is a member of the College of Law's Board of Visitors.

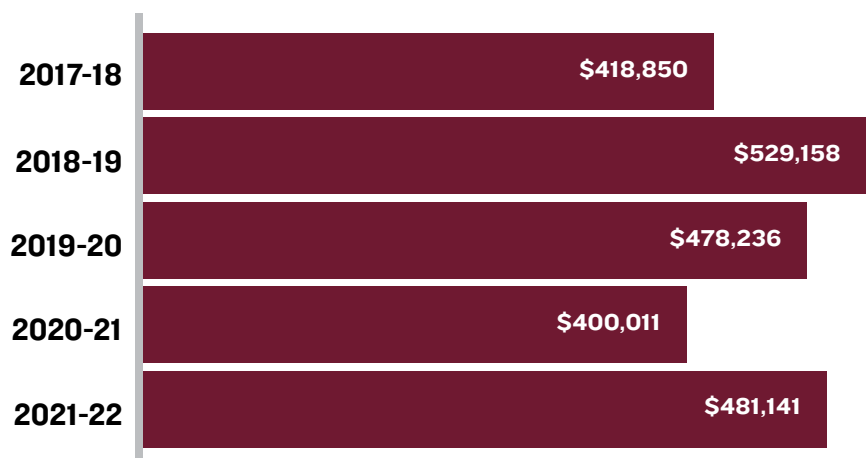
