Faculty and Alum Profile: Rob McNeely ('93)

Rob McNeely has been an adjunct professor at the FSU College of Law since 2004, teaching a popular course in Entertainment Law in the spring semester. McNeely practices at Messer Caparello, P.A., one of Tallahassee's oldest law firms. He has enjoyed a diverse statewide practice in his career. In addition to entertainment law, he has worked, lectured and published on topics in the areas of complex family law litigation and policy, legislative practice, civil litigation and transactions, intellectual property, land use and appellate practice. He has litigated civil and family law matters throughout Florida and litigated intellectual property law issues involving copyright and trademark law in federal courts in Florida, Nevada and Pennsylvania. He served as lead attorney for the band Creed from 2000-2004 and is a former award-winning journalist, mostly in public radio. McNeely serves as vice president of business and legal affairs, and an executive producer of Liner Notes Production, LLC, where he is instrumental in content and program creation, artistic vision, legal affairs, business development and strategic planning. He has also worked with Florida local governments navigating issues relating to beach access and customary use. McNeely is a triathlete, finishing more than 50 triathlons since his first one in November 2009, including Ironman Florida (2012) and Ironman Mont Tremblant (2014). He is past-president of the 300-member Gulf Winds Triathletes triathlon club in Tallahassee, is an ordained deacon at Faith Presbyterian Church in Tallahassee, and is married with four children and a stepdaughter. McNeely holds a bachelor's degree in journalism from the University of Kansas (1981) and a J.D. with high honors from the Florida State University College of Law, where he served on the Moot Court Team and as an executive editor of the *Florida State University Law Review*. Alum Profile: Kathleen J. "Kat" Klepfer ('14)

Kat Klepfer has been the research and access services librarian with the FSU College of Law Research Center since August 2017. Klepfer supervises the circulation department, teaches legal research courses, and assists with faculty and student research. She is a member of the Southeastern Chapter of the American Association of Law Libraries and currently serves as secretary and is chair of the Government Relations Committee. Prior to joining the FSU Law Research Center, Klepfer was the reference and research services librarian at the University of Richmond School of Law, where she taught legal research in the 1L Lawyering Skills Program, co-taught Public Policy Research & Drafting, provided extensive research support to faculty, and managed the library's archives and special collections. In addition to earning her J.D. *magna cum laude* and her M.S. in library and information science from FSU in 2014, she has a B.A. from the University of Florida in classical studies.

Alyson Morelli graduated *cum laude* from FSU Law in May 2018. She earned the Business Law Certificate in addition to her J.D. Originally from Ormond Beach, Morelli earned a bachelor's degree in economics from FSU. During law school, she was a member of the *Florida State University Law Review* and also served as assistant articles and notes editor for the *Journal of Transnational Law & Policy*. Morelli served as 1L representative, vice president and president of the Real Property, Probate and Trust Law Society. During her term, Morelli implemented networking events and a mentorship program for members. During her first two years of law school, Morelli also served in leadership roles for the Women's Law Symposium and earned the distinguished pro bono certificate for her involvement with FSU Law's Alternative Spring Break Program. In this position, Morelli performed high-volume document review on Everlaw, led a quantitative research review to evaluate economic data in preparation for litigation, and conducted other factual research and document production projects at different stages of litigation. She also contributed to drafting complex multiparty complaints. During her 3L year, Morelli clerked at King & Wood, P.A., where she conducted legal research on probate law, conflicts of law and business law matters. 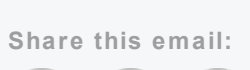
