Faculty Profile: Mark Spottswood

Professor Mark Spottswood joined the FSU Law faculty in 2010. He teaches Evidence, Civil Procedure, Scientific Evidence and Advanced Civil Procedure. Spottswood focuses his research on the design of the trial process, investigating how we might make civil and criminal litigation more accurate, more acceptable and more cost-effective through reforms to the rules of procedure and evidence. His recent work has explored the proper interpretation of the Confrontation Clause, some challenges involved in communicating probabilistic concepts to jurors, and the ways in which the order of proof at trial can influence jury decision making. Spottswood received a University Graduate Teaching Award from FSU for 2016-2017, and is a regular coach for our Moot Court Team. He clerked for both the Honorable Jeffrey S. Sutton, United States Court of Appeals for the Sixth Circuit, and the Honorable Rebecca R. Pallmeyer, United States District Court for the Northern District of Illinois. He earned his bachelor's and law degrees from Northwestern University.



“Throughout my career, I have been fascinated by trials. The trial process embodies our highest aspirations regarding the courts’ ability to unravel deception and discover the truth, but in recent years we have seen disturbing evidence suggesting that the results of jury trials may be wrong far more often than we would wish. In my research, I draw on psychological research to search for ways that we can reduce the frequency of wrongful verdicts. In the classroom, I do my best to strike a balance between showing students the best ways to achieve positive results for their clients under the rules as they exist now, while also preparing them to take an active role in improving our justice system for the benefit of future generations. I am constantly impressed by our students’ enthusiasm for both kinds of understanding.”

Alum Profile: Tracey L. Ellerson ('97)

Tracey Ellerson serves as vice president, chief compliance officer, for Brambles Limited, an international supply-chain logistics company. She helps Brambles and its group companies comply with all applicable laws and regulations in the approximately 60 countries in which they do business. Ellerson develops global programs—policies, procedures, trainings, and other resource guides—in areas including anti-bribery and anti-corruption; competition; import, export and sanctions controls; data privacy; and information security incident response. She is based in Atlanta, but frequently travels to Brambles offices worldwide to meet with local business teams. Prior to joining Brambles in 2015, Ellerson was a partner at BakerHostetler LLP in Orlando, where she served as a co-leader of the firm’s Employment and Labor Class Action Team. She also practiced at Akerman Senterfitt, P.A. after graduating from law school. While in Orlando, she served on the Coalition for the Homeless of Central Florida’s Board of Directors, volunteered as a guardian ad litem, and was a member of the United Way’s Central Florida Women’s Leadership Steering Committee.

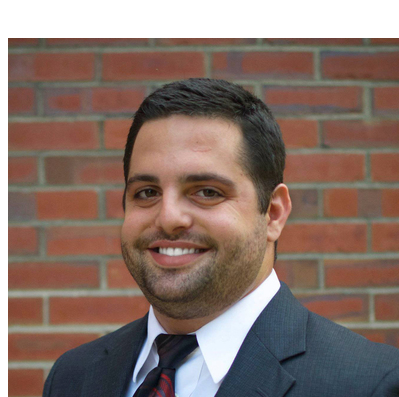

Student Profile: 2018 Grad Cole Masterson

May 2018 FSU Law graduate Cole Masterson holds a bachelor’s degree in psychology from Florida State University, where he was a member of the FSU Rugby Team and FSU Marching Chiefs. Originally from Bradenton, Masterson was a staff editor for the *Florida State University Law Review*. He also worked as a pro bono research assistant for the FSU Institute for Family Violence Studies, where he co-drafted an amicus curiae brief regarding transgender representation in modern culture and media to be filed in an upcoming case. He also won a book award for Legal Writing and Research I. The summer after his 1L year, Masterson clerked for Matthew Erjavec, P.A. In this role, he engaged in all aspects of personal injury cases, including negotiating with insurance adjusters and medical professionals to obtain optimal damages for clients. During that summer, Masterson also provided per-project services for Soler & Slack, P.A. He researched various areas of criminal law and drafted a motion to suppress evidence, which was filed in a criminal case and was instrumental in reducing the client’s sentence. Masterson clerked for the Law Office of Fred Pearson, P.A. during the fall semester of his 3L year. He researched issues, prepared memoranda, drafted legal complaints, composed demands and corresponded with insurance agents, health providers and parties working toward the resolution of personal injury cases. 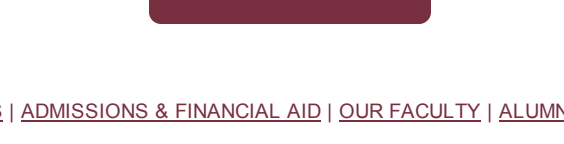

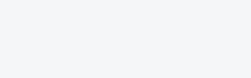
