THE COLLEGE OF LAW'S ENVIRONMENTAL FORUM SERIES: 2006 PROGRAMS

The Law School launched its *Environmental Forum Series* in 2003 as a way to provide a neutral forum for the discussion of timely environmental issues.

Our November 2006 *Environmental Forum*, which the College of Law co-sponsored with the Environmental and Land Use Section of The Florida Bar, focused on **The Role of Marine Reserves in a Fisheries Management Strategy**.

Marine reserves are essentially ocean "wilderness" areas: all extractive and disruptive activities are prohibited within a reserve. The reserves have proved controversial. While some tout marine reserves for the benefits they bring to ecosystems and fishery populations, fishermen, among others, have raised concerns that use of such reserves is not sufficiently supported by science to justify the complete closure of such areas to such important economic use. The details of reserves have proved challenging as well, as scientists have been working diligently on issues of size and location to determine how marine reserves can be used optimally.



Our fall *Forum* featured leading experts on the topic, including: Professor **Felicia Coleman**, Director of the FSU Coastal and Marine Laboratory, a Pew Marine Conservation Fellow and an Aldo Leopold Leadership Program Fellow; Professor **Robin Craig**, Attorneys' Title Insurance Fund Professor, FSU College of Law; **Charles Shelfer**, Deputy General Counsel, Florida Fish and Wildlife Conservation Commission; and **David White**, Director, South Atlantic regional office of The Ocean Conservancy (TOC).

Professor **Donna Christie**, a leading authority on legal issues surrounding ocean and coastal management law and policy, moderated the program, and **Lauren Moody**, President of the FSU Environmental Law Society, introduced it.

ELS COMMUTER CHOICES WEEK

According to the Florida Department of Environmental Protection, auto emissions are the number one source of air pollution in Florida. To raise student awareness of the issue, the Environmental Law Society sponsored a "Commuter Choices" campaign the week of October 30 - November 3, as part of the National Association of Environmental Law Societies' Campus Climate Neutral campaign.

Members of ELS provided information on alternate transportation systems in the Tallahassee area, such as biking, carpooling, and riding the city bus. Lauren Moody, president of ELS, encourages students by example - she saves almost \$80 a month by biking four miles round-trip from her home to the College of Law.

The ELS is exploring ways to make FSU a more sustainable campus and will be implementing a plan of action this spring.

"Our first Alternative Transportation Week was a huge success. A big part of it was raising awareness that many commuters in Tallahassee do not have a choice but to drive alone to work or school. We were very pleased with the level of enthusiasm and participation and we plan to make it a semi-annual event.

Next semester we will be focusing on the Campus Climate Neutral campaign. We have some great ideas for reducing energy consumption on our campus and we hope to get other departments of the University involved with the project"

FACULTY ENRICHMENT WORKSHOPS AND GUEST LECTURERS IN OUR ENVIRONMENTAL CERTIFICATE SEMINAR

Three distinguished environmental law professors participated in the College of Law's faculty workshop series this fall and gave guest lectures to the College of Law's Environmental Certificate Seminar. Fifteen students are projected to graduate with a certificate in May 2007.

JEREMY JUNGREIS, ENVIRONMENTAL LAW MENTOR

Major Jeremy Jungreis, class of 1996, is a U.S Marine Corps special counsel in environmental law. Major Jungreis serves as lead agency counsel for complex federal water rights and water quality litigation in the Central District of California. He also recently briefed the Chairman of the California Air Resources Board on alternative fuel use and greenhouse gas reduction in the Department of Defense. In addition, Major Jungreis has taught environmental law both in the United States and overseas, and has been published in the Harvard Environmental Law Review

TOM PELHAM, CO-CHAIR OF THE ENVIRONMENTAL ALUMNI GROUP

Tom Pelham, class of 1971, has a statewide practice in governmental, environmental and land use law with Fowler White Boggs Banker P.A. in its Tallahassee office. He also teaches Growth Management as an adjunct professor at the FSU Law School. Pelham's commentary on the twentieth anniversary of Florida's 1985 Growth Management Act was published in the July, 2006 issue of *Planning and Environmental Law*, and his article, *The Role of the Local Comprehensive Plan as Law: Some Lessons From Florida*, was published in *PLANNING REFORM IN THE NEW CENTURY* (APA, 2005).



In March, 2006, Pelham gave a presentation on Florida's coastal planning and regulatory programs at the LSU Second Presidents' Forum on Meeting Coastal Challenges in Baton Rouge, La. A certified planner, Pelham serves on the Legislative Policy Committee of the American Planning Association, Florida Chapter, and in September, 2006, he received the Chapter President's Award for Outstanding Contributions to the Chapter.

Joe Ullo, class of 2006, participated in The Florida Bar ELULS's 2006 Dean Frank E. Maloney Memorial Writing Contest. His paper titled "Adding Pollution Trading to Florida's Total Maximum Daily Load Program" won first place. Joe is an associate at Lewis, Longman and Walker, P.A. in Jacksonville.

Shelbie Legg, class of 2002, recently was appointed vice-consul at the U.S. Embassy in Tashkent, Uzbekistan after working as an attorney for the Florida Department of Environmental Protection. In addition, she is responsible for assisting Americans with a variety of issues when they visit or relocate to Uzbekistan.
