INSTRUCTIONS

Method A:

1. Using a computer from any FSU library, go to the FSU Library's homepage at <http://www.lib.fsu.edu>.
2. Select "Basic Catalog Search."
3. Type the title of the book in the empty text box.
4. Choose "Title."
5. Hit "Submit Search."

Click the NetLibrary link immediately following "*Bibliographic record display*" of the title you are searching.

Method B:

1. Open your browser at a computer in the Law Library.
Type in the long Internet address in the address bar and hit *Enter*.

Method C:

Ask a reference librarian.
