RESPONSE TO PETITION FOR LEAVE TO RESIGN

COMES NOW, The Florida Bar, and files this response to the petition for leave to resign pursuant to The Florida Bar Integration Rule, Article XI, Rule 11.08, and says:

1. The petitioner has filed his petition for leave to resign dated December 10, 1985. The Florida Bar has previously filed in this Court two formal complaints concerning this petitioner, Nos. 62,672 and 67,245, which are still pending.

2. The Board of Governors of The Florida Bar considered this petition at its January, 1986 meeting, and voted to support the resignation including petitioner's agreement to pay costs which have been computed at \$6,759.19.

3. Granting the petition will not adversely affect the public interest, affect the purity of the courts nor hinder the administration of justice, nor the confidence of the public in the legal profession. Should this Court grant this petition it is requested that the Court publish a public opinion stating succinctly the reasons therefor as provided in The Florida Bar Integration Rule, Article XI, Rule 11.12(2).

WHEREFORE, The Florida Bar respectfully urges this Court to accept the petition for leave to resign, to assess the costs of this proceeding as indicated in paragraph 9 of the petitioner's petition and to publish an opinion containing the matters leading to this resignation.




