COMES NOW, the Petitioner, Joseph Mason, by and through his undersigned attorney and files this his brief on jurisdiction for the court to invoke discretionary jurisdiction on Writ of Certiorari and would state as follows:

1. This Court has presently pending before it awaiting decision on conflict of decisions in the cases of Gant v. Tallahassee Memorial Regional Medical Center, 490 So.2d 1020 (1st DCA 1986) and Fleming v. Barnett Bank of East Polk County, 490 So.2d 126 (2d DCA 1986) which have been certified to the Supreme Court from the Second District Court of Appeals as being in direct conflict with a First District case.

2. The issue in the present case is the same issue awaiting decision by this court in Fleming, supra, and Gant, supra.


