## Faculty Profile: Melissa O. Hanson

Legal Writing Professor [Melissa O. Hanson](#) teaches Legal Writing and Research I and II, as well as Federal Courts. She is also the track director for the Legal Risk Management and HR Compliance concentration of the new online Juris Master program for non-lawyers and created the course materials for the Employment Law and Employment Discrimination courses for the J.M. program. Hanson was recently selected as a recipient of the 2016-17 University Graduate Teaching Award for excellence in teaching. Prior to joining FSU Law in 2014, Hanson spent 11 years as a career law clerk to two federal judges, U.S. Magistrate Judge Monte C. Richardson and U.S. District Judge Brian J. Davis, both of the United States District Court for the Middle District of Florida. In addition, she spent seven years at Foley and Lardner, where she specialized in labor and employment litigation. Hanson graduated second in her class from the University of Florida College of Law, where she served on the *Florida Law Review* and was elected to the Order of the Coif. She earned her bachelor's degree from the University of California, Berkeley.

## Alum Profile: Diego "Woody" Rodriguez ('95)


Diego "Woody" Rodriguez is general counsel for Orange County Public Schools (OCPS), the ninth largest school district in the country with more than 200,000 students. He advises the Orange County School Board and the superintendent for OCPS on education-related legal matters, including public records disclosures, labor relations and employment law matters, student expulsions, land use and zoning matters, compliance with ethics and election laws, general transactional matters and construction and finance issues. Prior to joining OCPS in 2010, Rodriguez was in private practice, representing several Orange County governmental entities including the Supervisor of Election's Office. Since 2006, Rodriguez has been board certified in City, County and Local Government Law. He has always been involved in local bar associations, serving as past president of the Young Lawyers Section, the Hispanic Bar Association and becoming the first minority to serve as president of the Orange County Bar Association in 2009. Rodriguez also remains engaged with the law school – last spring he co-hosted a special lunch for current and admitted students, judges and alums as part of a Judge Shadow Day in Orlando and he headed up the 20-year reunion for the Class of 1995.

Originally from Cochran, Ga., Regan Urquhart earned a B.A. in international affairs and a B.S. in sociology from the University of Georgia. She is currently pursuing a master's degree in international affairs at FSU and will complete her J.D. and joint degree this summer. Urquhart is a member of the Women's Law Symposium, the Association of Criminal Justice and the Transfer Student Organization. During her law school career, Urquhart worked as a summer associate at the Immigration Advice and Rights Center in Sydney, Australia. Last spring, Urquhart was a legal assistant at the Law Office of Anabelle Dias, P.A., a criminal defense firm in Tallahassee. While there, she gained experience researching a variety of criminal issues, such as evidence suppression and double jeopardy. On multiple occasions she met with clients in county jails and this experience helped her realize her interest in criminal law. Last summer, Urquhart was a judicial intern for the Department of Justice Executive Office for Immigration Review at the Krome Immigration Detention Center in Miami. This spring she is working with the Public Defender's Office in Tallahassee. During her remaining time in law school, Urquhart plans to concentrate her studies in criminal and immigration-related courses. Outside the classroom, Urquhart is a Guardian ad Litem and is always looking for innovative ways to give back to the community. 
