


## From the Dean



In May, the *Florida State University Law Review* launched a new online publication, the *Florida State University Law Review Online*. The new digital publication features timely short essays, response pieces and case notes. The first issue is dedicated to the friends and family of FSU Law, featuring pieces written by former *FSU Law Review* members Timothy Asta ('17), Melanie Kalmanson ('16) and the Honorable John G. Van Laningham ('88). Another component of the new online forum is the *Florida State University Law Review Rehearing*. The *Rehearing* is a virtual initiative that provides a unique and innovative platform for leading scholars to weigh in on important and pressing legal issues. The entire discussion is conducted remotely via teleconference, recorded and then transcribed, published and searchable via HeinOnline, Westlaw and Lexis. The audio recording and transcript are also posted in the online publication. The inaugural *Florida State University Law Review Online* is [available now](#). Moderated by FSU Law's Elizabeth C. & Clyde W. Atkinson Professor Erin Ryan, the first *Rehearing* addressed issues in a case before the Ninth Circuit, *Juliana v. United States*, and its transcript will be available later this summer. Congratulations to our students, especially Editor-in-Chief Danny Buchholz ('18), as well as Sam Walenz ('18), Elisa Walker ('17) and Jazz Tomassetti ('17), who worked tirelessly to bring the online publication and *Rehearing* to life.

## Faculty Profile: Mark R. Schlakman

Mark R. Schlakman serves as senior program director for the Florida State University Center for the Advancement of Human Rights, and coordinator of its Human Rights & National Security in the 21st Century lecture series. He taught Immigration Law (which also incorporates refugee protection issues) during the spring semester, is teaching Felony Disenfranchisement in Florida this summer and will teach Executive Clemency in Florida this fall. He previously taught Human Rights & National Security, and teaches related courses on main campus through the College of Social Sciences (and its Osher Lifelong Learning Institute). Schlakman is a recipient of a 2015 Guardian of the Flame Award that Burning Spear presented to him for outstanding service to the College of Social Sciences and the university. He held senior positions in state and federal government prior to transitioning to FSU in 2002, including assistant general counsel and clemency aide, and ultimately special counsel to Governor Lawton Chiles; as an adviser to then-incoming Governor Jeb Bush during transition; and as a foreign affairs officer within the White House Office of the Special Envoy to the Americas during the latter stages of the Clinton administration. Schlakman was reassigned to the U.S. Department of State at the outset of the George W. Bush administration where he earned a Superior Honor Award for his service, also as a special assistant and interim foreign policy advisor to then-Commander of the U.S. Southern Command Peter Pace, USMC. Schlakman has participated in the command's Human Rights Initiative under multiple commanders. He was retained as a subject matter expert by COL Emilio Gonzalez (Ret.), Ph.D., Director, U.S. Citizenship and Immigration Services within the U.S. Department of Homeland Security during the latter stages of the George W. Bush administration. He is a member of the U.S. Attorney for the Middle District of Florida's Hate Crimes and Civil Rights Working Group, and the U.S. Global Leadership Coalition's Florida Advisory Committee. He served on the American Bar Association's eight-member Florida Death Penalty Assessment Team, and is a past and the longest serving board chair of The Innocence Project of Florida. Schlakman has addressed a range of issues before legislative committees and the Florida Constitution Revision Commission, is eligible to practice law in Florida, is a member of various Bar sections and is a frequent contributor to state and national media outlets. He earned his bachelor's degree from the University of Miami *magna cum laude* and his J.D. from the Georgetown University Law Center in Washington, D.C., serving as SBA president. He completed Harvard University's Kennedy School post-graduate Program for Senior Executives in State and Local Government while on Chiles' staff.
