Each year, FSU Law faculty members are called upon to serve in leadership roles. For the upcoming 2019-2020 academic year, the following professors are serving as associate deans. Shawn J. Bayern, the Larry and Joyce Beltz Professor of Torts, will serve as associate dean for academic affairs. Manuel A. Utset, the William & Catherine VanDercreek Professor, who has served in the associate dean for academic affairs role since 2014, will transition into a newly created deanship, the associate dean for juris master programs. Courtney Cahill, the Donald Hinkle Professor, will serve as associate dean for research, replacing Mark B. Seidenfeld, the Patricia A. Dore Professor of Administrative Law. 
