


## From the Dean

## Public Interest Law Center Students Honored



The Public Interest Law Center honored student award winners virtually in April.

On Friday, April 23, FSU Law’s Public Interest Law Center (PILC) held its second annual awards ceremony virtually. Glass Professor of Public Interest Law Paolo Annino presented the awards and was joined by Clinical Professors Carla Laroche and Darby Scott in speaking to the students’ character and merit. Oluremi “Remi” Abiodun (’21) (pictured above, top row, center) received the Clinical Legal Education Association’s (CLEA) Outstanding Clinical Student Advocate Award, which is given to one clinical student per law school who has demonstrated excellence in class participation and client advocacy. Professor Scott said Abiodun is “a fierce advocate for social justice and for everything that’s right in the world.” Lily McLaughlin (’21) (pictured above, top row, far left) received PILC’s Advocate on the Rise Award for demonstrating growth in public interest advocacy. Professor Annino shared that McLaughlin consistently went above and beyond in serving and developing trust with PILC clients, without ever seeking acknowledgement. The students also spoke about what receiving the awards meant to them and thanked their professors and classmates for the wonderful experiences they had while participating in PILC clinics.

The ceremony also celebrated PILC’s efforts and accomplishments on behalf of their clients and ended with participants sharing about the pets, plants and companions that accompanied them through the year.

Zach Wiseman grew up in Spring Hill, Florida. He earned a bachelor’s degree in history from the University of Florida and graduated from FSU Law in April 2021. This spring, Wiseman worked as a certified legal intern at the Office of the Public Defender, Second Judicial Circuit, where he managed a caseload of around 80 cases. He worked directly with clients, represented them in court, gave legal advice, performed legal research, drafted motions and even had opportunities to speak and argue on the record in contested hearings. During the summer of 2020, Wiseman participated in the FSU Public Interest Law Center (PILC) Veterans Legal Clinic. As a certified legal intern, he worked directly with clients, conducted legal writing and research, gave legal advice and drafted documents. During the fall semester of his 2L year, Wiseman externed with the Office of the Public Defender, Second Judicial Circuit. He worked in the felony division, researching and working on some evidentiary issues. He spent his 1L summer and his 2L fall semester participating in the PILC Immigration and Farmworker Project. There, he worked directly with clients on various immigration cases and conducted legal writing and research.
